# Statement of Faith

Students, Faculty, and Teammates agree with the beliefs expressed in this Statement and commit to living in accordance with these beliefs.

#### Holy Bible

The Holy Bible, and only the Bible, is the authoritative Word of God. It alone is the final authority in determining all doctrinal truths. In its original writing, it is inspired, infallible, and inerrant. (II Timothy 3:16; II Peter 1:20-21; Proverbs 30:5; Romans 16:25-26)

#### **Trinity**

There is one God, eternally existent in three persons: Father, Son, and Holy Spirit. These three are coequal and coeternal. (I John 5:7; Genesis 1:26; Matthew 3:16-17, 28:19; Luke 1:35; Isaiah 9:6; Hebrews 3:7-11)

#### Jesus Christ

Jesus Christ is God the Son, the second person of the Trinity. On earth, Jesus was 100% God and 100% man. He is the only man ever to have lived a sinless life. He was born of a virgin, lived a sinless life, performed miracles, died on the Cross for mankind and thus, atoned for our sins through the shedding of His blood. He rose from the dead on the third day according to the Scriptures, ascended to the right hand of the Father, and will return again in power and glory. (John 1:1,14,20:28; I Timothy 3:16; Isaiah 9:6; Philippians 2:5-6; I Timothy 2:5)

#### Virgin Birth

Jesus Christ was conceived by God the Father, through the Holy Spirit (the third person of the Trinity) in the virgin Mary's womb; therefore, He is the Son of God. (Matthew 1:18,25; Luke 1:35; Isaiah 7:14; Luke 1:27-35)

#### Redemption

Man was created good and upright, but by voluntary transgression he fell; his only hope of redemption is in Jesus Christ, the Son of God. (Genesis 1:26-31, 3:1-7; Romans 5:12-21)

#### Regeneration

For anyone to know God, regeneration by the Holy Spirit is absolutely essential. (John 6:44, 65; Matthew 19:28; Titus 3:5)

#### Salvation

We are saved by grace through faith in Jesus: His death, burial, and resurrection. Salvation is a gift from God, not a result of our good works or of any human efforts. (Ephesians 2:8-9; Galatians 2:16, 3:8; Titus 3:5; Romans 10:9-10; Acts 16:31; Hebrews 9:22)

#### Repentance

Repentance is the commitment to turn away from sin in every area of our lives and to follow Christ, which allows us to receive His redemption and to be regenerated by the Holy Spirit. Thus, through repentance we receive forgiveness of sins and appropriate salvation. (Acts 2:21; 3:19; I John 1:9)

#### Sanctification

Sanctification is the ongoing process of yielding to God's Word and His Spirit to complete the development of Christ's character in us. It is through the present ministry of the Holy Spirit and the Word of God that the Christian is enabled to live a Godly life. (I Thessalonians 4:3, 5:23; II Corinthians 3:18, 6:14-18; II Thessalonians 2:1-3; Romans 8:29; Hebrews 2:11)

#### Jesus' Blood

The Blood that Jesus Christ shed on the Cross for both our sinfulness and our sins, enabling all those who believe to be free from the penalty of sin, which is death. (I John 1:7; Revelation 1:5, 5:9; Colossians 1:20; Romans 3:10-12, 23, 5:9; John 1:29)

#### Jesus Christ Indwells All Believers

Christians are people who have invited the Lord Jesus Christ to come and live inside them by His Holy Spirit. They relinquish the authority of their lives over to him thus making Jesus the Lord of their life as

well as Savior. They put their trust in what Jesus accomplished for them when He died, was buried, and rose again from the dead. (John 1:12; John 14:17, 23; John 15:4; Romans 8:11; Revelation 3:20)

#### Baptism in the Holy Spirit

Given at Pentecost, it is the promise of the Father, sent by Jesus after His Ascension, to empower the Church to preach the Gospel throughout the whole earth, one of the signs being speaking in other tongues along with other gifts. (Joel 2:28-29; Matthew 3:11; Mark 16:17; Acts 1:5, 8, 2:1-4, 17, 38-39, 8:14-17, 10:38, 44-47, 11:15-17, 19:1-6)

#### The Gifts of the Holy Spirit

The Holy Spirit is manifested through a variety of spiritual gifts to build and sanctify the church, demonstrate the validity of the resurrection, and confirm the power of the Gospel. The Bible's lists of these gifts are not necessarily exhaustive, and the gifts may occur in various combinations. All believers are commanded to earnestly desire the manifestation of the gifts in their lives. These gifts always operate in harmony with the Scriptures and should never be used in violation of Biblical parameters. (Hebrews 2:4; Romans 1:11, 12:48; Ephesians 4:16; I Timothy 4:14; II Timothy 1:6-7; I Corinthians 12:1-31, 14:1-40; I Peter 4:10)

#### The Church

The church is the Body of Christ, the habitation of God through the Spirit, with divine appointments for the fulfillment of Jesus' Great Commission. Every person who is born of the Spirit is an integral part of the church as a member of the body of believers. There is a spiritual unity of all believers in our Lord Jesus Christ. (Ephesians 1:22, 2:19-22; Hebrews 12:23; John 17:11, 20-23)

#### Sacrament of Water Baptism

Following faith in the Lord Jesus Christ, the new convert is commanded by the Word of God to be baptized in water in the Name of the Father and of the Son and of the Holy Spirit and by full immersion. (Matthew 28:19; Acts 2:38; Mark 16:16; Acts 8:12, 36-38, 10:47-48)

#### Sacrament of the Lord's Supper

A unique time of communion in the presence of God when the elements of bread and grape juice (the symbols of Body and Blood of the Lord Jesus Christ) are taken in remembrance of Jesus' sacrifice on the Cross. (Matthew 26:26-29; I Corinthians 10:16, 11:23-25)

#### Sacrament of Marriage

We believe that because God our Creator established marriage as a sacred institution between one man and one woman, marriage is a covenant only between one man and one woman, as clearly conveyed in God's inerrant Scriptures, including for example in Matthew 19:4-6 where in speaking about marriage Jesus referred to the fact that "he which made them at the beginning made them male and female." (Genesis 1:27, 5:2)

#### Sexuality

We believe sexuality and the divinely prescribed boundaries for its expression are covered clearly in the Holy Scriptures, which limit sexual expression to the marital relationship of one man with one woman. Homosexual acts, adultery, bestiality, and all forms of fornication are categorically condemned in the Holy Scriptures. We believe that sexuality is assigned by God at conception, male or female, whatever that may be, and the Holy Scriptures does not permit an individual to alter their sexual identity physically or otherwise. (Deuteronomy 23:1; I Corinthians 6:18; I Thessalonians 4:3; Romans 1:26-27; Proverbs 5:3-5, 8-13; 7:21-27; Galatians 5:19; Exodus 20:14; Deuteronomy 5:18; Matthew 5:27; 19:18; Luke 18:20; Romans 13:9; James 2:11; Leviticus 20:10-21; I Corinthians 10:8; Jude 7)

#### Healing of the Sick

Healing of the sick is illustrated in the life and ministry of Jesus and included in the commission of Jesus to His disciples. It is given as a sign, which is to follow believers. It is also a part of Jesus' work on the Cross and one of the gifts of the Spirit. (Psalm 103:2-3; Isaiah 53:5; Matthew 8:16-17; Mark 16:17-18; Acts 8:6-7; James 5:14-16; I Corinthians 12:9, 28; Romans 11:29)

#### God's Will for Provision

It is the Father's will for believers to become whole, healthy, and successful in all areas of life. But because of the fall, many may not receive the full benefit of God's will while on earth. That fact, though, should never prevent all believers from seeking the full benefits of Christ's provision to better serve others.

- 1. Spiritual (John3:3-11; II Corinthians 5:17-21; Romans 10:9-10)
- 2. Mental and Emotional (II Timothy 1:7, 2:11; Philippians 4:7-8; Romans 12:2; Isaiah 26:3)
- 3. Physical (Isaiah 53:4-5; Matthew 8:17; I Peter 2:24)
- 4. Financial (Joshua 1:8; Malachi 3:10-11; Luke 6:38; Il Corinthians 9:6-10; Deuteronomy 28:1-14; Psalm 34:10, 84:11; Philippians 4:19)

#### Resurrection

Jesus Christ was physically resurrected from the dead in a glorified body three days after His death on the Cross. In addition, both the saved and the lost will be resurrected; they that are saved to the resurrection of life and they that are lost to the resurrection of eternal damnation. (Luke 24:16, 36, 38; John 2:19-21, 20:26-28, 21:4; Acts 24:15; I Corinthians 15:42; Philippians 1:21-23)

#### Heaven

Heaven is the eternal dwelling place for all believers in the Gospel of Jesus Christ. All of God's children will reign forever in a new heaven and a new earth. \*Matthew 5:3, 12, 20, 6:20, 19:21, 25:34; John 17:24; Il Corinthians 5:1; Hebrews 11:16; I Peter 1:4; Revelation 21:1-5)

#### Hell

After living one life on earth, the unbelievers will be judged by God and sent to Hell where they will be eternally tormented with the Devil and the Fallen Angels. (Matthew 25:41; Mark 9:43-48; Hebrews 9:27; Revelation 14:9-11, 20:12-15, 21:8)

#### **Second Coming**

Jesus Christ will physically and visibly return to earth for the second time to establish His Kingdom. This will occur at a date undisclosed by the Scriptures. (Matthew 24:30, 26:63-64; Acts 1:9-11; I Thessalonians 4:15-17; II Thessalonians 1:7-8; Revelation 1:7)

# Admission Requirements

HCLI is a part-time extended education program for adult learners to pursue leadership, ministry, and spiritual development. Applicants must meet the following requirements to be accepted into HCLI:

- 1. Meet the minimum age requirement of 23 years by the first day of class. Age exceptions may be permitted in very limited circumstances at the discretion of the HCLI Academic and Enrollment Committee.
- 2. Be a United States citizen.
- 3. Be a committed follower of Christ.
- 4. Demonstrate a strong sense of the call of God on their life.
- 5. Be a current, regular, and active member of a local church for at least three months.
- 6. Ensure access to sufficient financial resources to cover tuition, fees, and expenses.
- 7. Be a graduate of an accredited four-year high school, equivalent homeschool or receive a GED.
- 8. Affirm agreement with the Highlands College Statement of Faith.
- 9. Apply and complete all application requirements.

The HCLI Admissions Team reviews the application information, and the HCLI Admissions Team notifies the applicant of a decision. In some cases, an applicant may be asked to provide additional evidence that they meet these requirements, or the HCLI Admissions Committee may apply additional conditions concerning the above entry requirements.

#### **Application Process**

The application process consists of a completed online application form with the submission of all certificate-specific requirements and supporting documentation. The application for admission is on the HCLI website, <a href="https://hcli@highlandscollege.edu">hcli@highlandscollege.edu</a>. Once the application package, including all required supporting documentation, is complete, the HCLI Admissions Committee will review the application and make an admission decision. The HCLI Admissions Department will notify applicants of the outcome of their application. Applicants accepted for admission who do not enroll in the application year for which they applied must complete a new application for admission for another application year.

#### **Background Authorization Consent**

All applicants are required to approve a background check. If there are questions or issues regarding the applicant's background, the HCLI Admissions Committee, in partnership with the Security Department, will decide whether the applicant qualifies to enroll.

#### Student Information Release

HCLI is committed to student safety, growth, and development as individuals prepare for ministry. During a student's enrollment, situations may arise where student information needs to be shared between HCLI departments and Church of the Highlands leaders. Student privacy is essential, and HCLI seeks to maintain appropriate discretion regarding information sharing.

#### **Technical Standards**

HCLI is a comprehensive extended education experience that places specific requirements and standards on the students who enroll. Detailed technical standards deliver the essential qualities considered necessary for HCLI students to achieve the knowledge, skills, and competencies needed to serve at the highest level. These qualities inform technical standards for admission to HCLI.

All students admitted to HCLI must be qualified to pursue fulfilment of the technical standards. If a student cannot fulfill these technical standards, with or without reasonable accommodation, HCLI will not admit the student. Compliance with the college's technical standards alone does not guarantee a student's eligibility for admission.

Candidates for selection must verify that they understand and can meet these technical standards with or without accommodation. If accommodations are requested, the HCLI Academics Committee will evaluate all students who state they can meet the technical standards of HCLI with reasonable accommodations and confirm that the stated condition qualifies as a disability under the applicable laws eligible for such. The committee will make a review of whether the accommodations requested are reasonable, considering whether accommodations would jeopardize the student's or the institution's educational process, including all coursework deemed essential for certificate completion. These abilities and skills, as determined by HCLI, are as follows:

- Observation Skills: A student must be able to use the sense of vision, hearing, and somatic sensation to assimilate information quickly and accurately in the classroom and in ministry training fields (as applicable).
- Communication Skills: Students must be able to read, speak intelligibly, and hear sufficiently to
  have an adequate exchange of information and create rapport with team members,
  congregation, and others. A student must be able to read and write English effectively to fulfill
  academic requirements and maintain accurate records as needed in ministry. Students must be
  able to accurately interpret verbal and nonverbal communications.
- Psychomotor Skills: Students must possess the physical skills, talents, and abilities to perform the essential physical task functions.
- Behavior and Social Skills: Students must possess the physical and emotional health required
  for the application of their intellectual abilities and the employment of sound judgment
  appropriately and promptly. Students must display emotional stability, a spirit of teamwork and
  cooperation, compassion, sensitivity, respect, honesty, reliability, perseverance, and concern for
  others in order to facilitate interpersonal relationships and provide effective pastoral care while
  maintaining appropriate professional boundaries. Students must exercise good judgment,
  accountability, professional integrity, strong interpersonal skills, and the ability to receive and
  integrate feedback.
- Cognitive Skills: These abilities include an aptitude for rapid problem solving, the capacity to independently access, interpret, and respond to academic and ministry information independently, and pastoral scenarios.

#### Application Denial and Reapplication

The HCLI Admissions team will notify applicants who are not accepted for readmission. An applicant denied admission can appeal the decision to the HCLI Admissions Committee if they feel additional information might influence the evaluation of their application.

If an applicant wishes to appeal an admission decision, they should submit the following items. The items for an appeal should be submitted via attachments in one email with the applicant's name and "Admission Decision Appeal" in the email's subject to <a href="mailto:hcliadmissions@highlandscollege.edu">hcliadmissions@highlandscollege.edu</a>.

- 1. Submit one to three letters of recommendation from pastors/staff from the church the applicant currently serves, including their contact information.
- 2. Submit a typed one-to-three-page essay answering the following questions:
  - a. Why do you feel called to attend HCLI?
  - b. Why do you think you will be successful at HCLI?
  - c. What have you done and are continuing to do to prepare yourself spiritually, mentally, emotionally, and physically for HCLI?
  - d. Are there additional factors not included in your initial application that you would like to have reconsidered?

HCLI will notify the applicant by email when all appeal requirements have been received. The HCLI Admissions Department will inform the applicant regarding a decision on the appeal within 15 business days of receipt of all appeal documents. Appealing an admission decision does not guarantee acceptance into HCLI. However, the HCLI Academic Review Committee will consider the items

mentioned above to determine if the additional information warrants acceptance. The deadline to submit all items for an admission appeal is the application deadline for each semester. Applicants denied admission may reapply five months from the date the prior application was submitted.

# **Financial Information**

#### **Outstanding Balances**

Any student whose account becomes past due 30-days, or more, is placed on financial lock. This prevents future course enrollment and the ability to request transcripts or certificates. Once the account is current, the financial lock will be removed. Students must have a zero balance to receive a certificate.

#### Refunds

Upon withdrawal from HCLI, a student may request a refund. The student is eligible for a full refund if they submit withdrawal paperwork by the end of the fourth week of a term.

#### **Financial Programs**

HCLI does not offer scholarships or participate in federal financial aid programs, such as Title IV or Veterans Administration.

# Certificate Programs

HCLI provides adult learners with the opportunity to earn non-credit bearing certificates. HCLI is designed for the part-time learner to pursue leadership, ministry, and spiritual development.

# Biblical/Theological Studies

The Biblical/Theological Studies certificate provides theological education for adult learners who want to further deepen their knowledge of the Bible and study of essential Christian beliefs. Biblical/Theological Studies classes follow the academic calendar and are on Tuesday nights from 6:00-6:55 p.m. CST. The Biblical/Theological Studies certificate consists of four courses designed to address the essential biblical and theological knowledge for a ministry-minded leader.

# Christian Leadership

This four-semester (two-year) certificate helps further develop your leadership with a Biblical worldview and foundation. In year one, you will build your personal and organizational leadership. In year two, you will build upon your personal leadership development by applying the principles in various settings, including your church, home, and workplace. Christian Leadership meets on Tuesday nights from 7:05 – 8:00 p.m. CST.

# Ministry Leadership

Taken in parallel with the Christian Leadership certificate, this certificate allows you to accelerate your ministry development through hands-on training and ministry experiences. Ministry Leadership is a four-semester course, and upon completion, you will be developed to serve at the highest level of your calling, whether vocationally or as a volunteer. Ministry Placement services are available to students who apply for and are eligible for placement assistance and complete all certificate requirements. #### Additional Requirements:

Students can declare a desire for placement assistance at the end of the first semester. Additional requirements for those students (these requirements must be completed prior to graduation):

#### **Sunday Serve Experiences:**

- Complete a total of thirty-six (36) Sunday Serves on the Church of the Highlands Dream Team
- Attend all three (3) steps of the Growth Track
- Serve one (1) step of the Growth Track
- Serve one (1) of each of the following services
  - At the Movies
  - Christmas service
  - Easter service
- Observe Production for one (1) service
- Participate in one (1) set-up and take-down (portable campuses only)

#### **Serve Experiences Monday – Saturday:**

- Serve two (2) conferences Can include summer conferences
- Create one (1) First Saturday Serve or Serve Day project. Student must register the project on the Serve App, build a team, execute the project, and reflect on its success.
- Attend, in person, eight (8) Saturday Morning Prayer or 21 Days of Prayer services.
- Observe one (1) Worship Development
- Serve one (1) Motion Night or Motion Mid-Week
- Serve one (1) Giving Hope

#### Other Requirements:

- Attend one (1) Ministry Training Intensive Saturday Lab offered each spring
- Complete one (1) 10k and serve one (1) 10k
- Complete and report thirty-six (36) workouts of 30 minutes or more.
- Lead three (3) small groups
- Complete or lead a Freedom small group

Upon successful completion of all courses and additional requirements, students will earn a Ministry Leadership certificate.

# Missions Leadership

In parallel with the Christian Leadership certificate, Missions Leadership exists to educate, train, and mobilize students who sense God leading them to serve in a global context among other cultures. The four courses will take place over one year and provide students with academic and practical training for cross-cultural missions. This certificate is a one-year class experience coupled with another year to complete the additional requirements for those seeking Placement assistance or pursuing a missions-related career opportunity. Missions Leadership meets on Tuesday nights from 6:00 – 6:55 p.m. CST. \*Christian Leadership is a co or pre-requisite for Missions Leadership.

Semester One:

Term A: MSL 011 Introduction to Missiology

Term B: MSL 012 Historical and Strategic Perspectives

Semester Two:

Term A: MSL 021 Culture and World Religions

Term B: MSL 022 Personal Leadership for Missionaries

Additional Requirements (for those seeking Placement assistance):

- Lead three (3) small groups, including one missions-themed group
- Attend or lead a Freedom small group
- Participate in six (6) cross-cultural outreaches and lead two (2) cross-cultural outreaches for a total of eight (8).
- Conduct a religious site visit
- Complete a Short-Term Mission Trip (Trips will be arranged by HCLI, but students can submit alternate trip options that meet the trip criteria to the HCLI team for approval.)
- Submit weekly workout journals
- Complete 48 Sunday Serves on the Church of the Highlands Dream Team
- Complete one 10k

Additional Requirements (for students **not** seeking Placement assistance):

- Lead small groups (2)
- Complete 24 Sunday Serves on the Church of the Highlands Dream Team

Upon successful completion of all courses and additional requirements, students will earn a Missions Leadership certificate.

# Student Services

#### Resolution Process

The resolution process provides a relational and equitable process to resolve student concerns. HCLI is committed to the scriptural principles found in Matthew 18:15-17. A direct approach between the offended person and the offender, "speaking the truth in love," when appropriate, will resolve most issues. Therefore, when appropriate, the student should first attempt to discuss the matter privately with the other person to reach a resolution.

If a student cannot resolve a concern with another student, HCLI team member, or a Church of the Highlands pastor or staff member, the student should follow the resolution process described below:

- 1. Students should express concerns by submitting a Resolution Form within 14 days of the occurrence. Resolution forms may be obtained by emailing <a href="mailto:hcli@highlandscollege.edu">hcli@highlandscollege.edu</a>. Forms should be submitted to <a href="https://hcli@highlandscollege.edu">hcli@highlandscollege.edu</a>.
- 2. The student will receive an acknowledgement of receipt of the information and can expect a timely response.

Every measure is taken to respect the student's concerns and protect the confidentiality of all information submitted. Students with specific concerns regarding their experience at HCLI are encouraged to use this form to make those known. HCLI Leadership will review and respond promptly to all completed forms.

HCLI Leadership is a small group of HCLI and Highlands College team members. Depending upon the nature of the concern and the response level needed, a member of HCLI Leadership may respond directly to the student. HCLI Leadership may also elevate the matter to the Office of the President for

review. HCLI cannot guarantee that it will resolve every issue raised to the satisfaction of a student or a group of students.

# **Policies**

# **Student Privacy**

The Family Educational Rights and Privacy Act (FERPA) is a federal law that protects the privacy of student education records. The law applies to all schools that receive funds under an applicable U.S. Department of Education program.

HCLI does not receive funds from the U.S. Department of Education and is not subject to FERPA. However, ethical principles for the confidentiality of student records are important to HCLI. The College has established policies and procedures that align with FERPA regulations.

#### Class Attendance

One of the most vital aspects of the HCLI experience is attendance and punctuality in the classroom. Class activities for each course have been specifically designed to enable students to meet the course's objectives. We encourage students to be present and punctual in class.

Attendance is collected and recorded for students pursuing Ministry Leadership and Missions Leadership certificates (including their co-requisite Christian Leadership classes). Attendance is not collected and recorded for students pursuing Christian Leadership and Biblical/Theological Studies certificates.

Students must monitor their class attendance to know they are approaching or have exceeded the maximum allowed. Students who exceed the maximum number of absences allowed for a class earn a failure due to attendance grade of "FA." The course grade is changed to "FA" only at the end of the semester.

The grade "FA" is recorded regardless of the student's grade in the course. A course in which the student earns a "FA" grade carries the same weight as if they earned an "F."

#### Number of Absences Allowed

For Ministry Leadership and Missions Leadership certificates (including Christian Leadership as corequisite), students are allowed 2 absences per eight-week term. Attendance is not collected for Christian Leadership and Biblical/Theological Studies certificates.

# Grading

At the end of each term, instructors assign a grade for every course. HCLI calculates grades on a pass/fail basis.

Grade Definition

P Pass = 70% or higher
F Failure = Less than 70%
FA Failure Due to Absences

#### **Academic Standing**

Students must pass their courses to remain in good academic standing.

#### Credit for Previous Coursework at Highlands College

Students may seek to return to Highlands College after a break in enrollment and be admitted. The HCLI Registrar will review the student's prior coursework and determine if the coursework is acceptable for certificate completion.

#### Course Registration

HCLI enrolls students in courses before the start of each semester. Students are encouraged to contact the HCLI Registrar with questions or concerns regarding the registration process and the scheduling of classes.

#### Course Withdrawal

Students can request a withdrawal at any time during the semester. Withdrawal forms are available from the HCLI Registrar. Students who withdraw receive a grade of "W."

#### Leave of Absence

Students who need to interrupt their studies temporarily for medical, personal, or employment reasons may request a Leave of Absence. A leave of absence permits students to cease attendance for a specified time and not have to apply for readmission. Students may request a leave of absence at any time and may be granted a leave of absence for one or two semesters. However, when the leave of absence ends, and the student returns, they must still meet all admission requirements. Students should contact the HCLI Registrar to submit a Leave of Absence. A \$50 Leave of absence fee will be applied to the student's account and must be paid within seven days. The fee will be applied to the student's tuition when they return.

#### **Grade Appeal**

Course assignment grade appeals must be addressed before the end of a course. If a student disagrees with a course assignment grade, the student should meet with the course instructor to discuss the disagreement before the end of the course.

#### **Grade Dispute**

If a student identifies an error in a course assignment grade or wishes to dispute a course grade after the end of the course, the following procedures and time limits apply.

- 1. The student's request should identify the rationale for the requested review and provide an explanation of why they did not raise the issue during the course.
- 2. The student should request to meet with the course instructor to discuss the assigned course grade and present supporting evidence to the course instructor no later than two weeks after the last day of the term or semester.
- 3. If the student does not receive a satisfactory explanation or resolution of the course grade in question, the student may then submit a written request for review to the HCLI Registrar within one week after the instructor's decision.
- 4. HCLI Leadership may then meet with the instructor, student, or both before deciding. The decision is final and is not subject to appeal.

#### Course Repeat

Students who earn a final grade of "F" or "FA" in any course must repeat it. There is a \$100 course repeat fee for each course the student repeats.

A student may repeat an individual course twice.

#### Withdrawal from HCLL

Student enrollment automatically renews each semester until one of the following events occurs:

- 1. Withdrawal
- 2. Dismissal
- 3. Expulsion
- 4. Non-payment of tuition
- 5. Prolonged non-attendance or inactivity exceeding 14-days
- 6. A Leave of Absence non-return

A student who decides to withdraw from HCLI must submit a withdrawal form to the HCLI Registrar. Students can obtain forms by emailing <a href="https://hcliregistrar@highlandscollege.edu">https://hcliregistrar@highlandscollege.edu</a>. A withdrawal conversation with the HCLI Registrar is strongly encouraged.

#### **Judicial Process**

Discipline is the responsibility of every member of the community. Self-discipline is the highest form of discipline, which links inextricably with a growing Christian lifestyle. However, when an individual does not execute self-discipline, discipline becomes the college community's responsibility. The following policies and procedures are not inclusive but describe the behavior inappropriate for HCLI students. Disciplinary action may occur if a student is found to violate the values and principles of Highlands College.

Depending on the circumstances and situation, especially those of a more serious nature with an impact of the individual or campus community, HCLI Leadership may need to become involved immediately with the goals of correction, safety, and growth in mind. Many scriptures inform our process, including Galatians 6:1-5, Hebrews 12:7-11, Matthew 18:15-17, 21-35, and Colossians 3:12-17.

#### Infractions

Infractions entail offenses that include but are not limited to the following:

- 1. Any action that violates the Highlands College Statement of Faith
- 2. Any action that violates the HCLI Community Covenant

#### Sanctions

Sanctions are determined by the HCLI Judicial Committee. Sanctions may vary given the nature and severity of the offense.

- 1. Warning: A written notice to the student that the student is violating or has violated institutional regulations.
- 2. Suspension: Temporary separation of the student from HCLI for a definite period, after which the student is eligible to return. Conditions for the student's return may be specified. If these conditions are not met, the student will be dismissed. Suspension follows the Leave of Absence protocol in this handbook.
- 3. Expulsion: Dismissal of the student from HCLI. The student is not eligible to return.
